Direction for Proposed Closure under Section 31A of the Air (Prevention and Control of Pollution) Act, 1981& Section 33A of the Water (Prevention and Control of Pollution) Act, 1974.

- WHEREAS, the Ministry of Environment, Forest and Climate Change, 1) New Delhi has Notified the Air (Prevention and Control of Pollution) Act, 1981 vide notification no. 14, dated-29.03.1981 for the prevention, control and abatement of air pollution.
- WHEREAS, the State Govt. has declared the entire State of Bihar as "Air-2) Pollution-Control-Area" under the provisions of section 19 of the Air (Protection and Control of Pollution) Act, 1981.

WHEREAS, you have been grated Consent-to-Operate 'Ready mix concrete batching plant (capacity: 30 m³/hour at Bihar Animal Science University, Bihar

Veterinary College Campus, Mauza- Amukudha and Samanpura, Thana no. 13 & 12, Revenue Thana- Phulwari, Dist-Patna vide Board's Ref. No. 2078, dated-25.08.2023 with the following conditions:

Condition no. 6: The unit shall provide adequate dust extraction/ suppression system at various dust generation points and comply with following:

All roads/vehicular movement area at the plant site should be pucca /stabilized with stone aggregates and regular sprinkler of water to be ensured so that no dust is generated due to vehicular movement.

- i. Ensure installation of water sprinkler/mist spraying facilities at points of dust emission within the premises like internal roads, working platform, loading and unloading areas. In addition they should be paved or concreted and kept clean all times.
- ii. The aggregates loading into hopper bin area shall be closed on three sides with metal sheets and the access side shall have plastic air curtains/multi sheet rubber flaps so as to arrest the emission generated during loading.
- iii. All aggregates stored within the premises shall not be stacked beyond the height of 3 m from the ground level.
- iv. Compound/boundary wall shall be provided on all four sides (except entrance) of the unit up to maximum height from the ground level for the purpose of wind fence.
- 4) WHEREAS, your unit was inspected on 02.11.2023 by the officials of the State Board and the following observations was made by the inspecting officers:
 - i. Construction activities were going on in 1,98,892sq, meter.
 - ii. Uncovered construction were observed.
 - iii. No water sprinklers were observed.
 - iv. Material transportation road not paved
 - v. Fugitive dust emission from RMC (0.5 M3) plant were observed.
 - vi. Road dust is not properly removed.
- WHEREAS, you have been granted Consent to Operate for 'Ready Mix Concrete Batching Plant (Capacity: 30 m3/hr) at Bihar Animal Science University in the new campus and operation of building construction but you have been found not complying the conditions mentioned above. You are violating the consent conditions of the Board, and you are liable to pay environmental compensation as per the guidelines of CPCB and the Environmental Compensation is calculated as Rs. 10,08,900/- (Rupee Ten

Lakh Eight Thousand Nine Hundred) only. Further the State Board is vested with powers to issue direction under Section 31A of the Air Act, 1981 & Section 33A of the Water Act, 1974 to protect the environment and Public Health.

I, therefore, in exercise of the powers under Section 31A of the Air Act, 1981 and Section 33A of the Water Act, 1974 propose to close your batching plant and submit the Environmental Compensation of Rs. 10,08,900/-(Rupee Ten Lakh Eight Thousand Nine Hundred) only for the said reason, you are hereby given an opportunity to file your objection, (if any), to the above proposed action of closure of your batching plant, within 10 days from the receipt of this notice, failing which directions, as proposed above, shall be confirmed against you and your batching plant will be directed to be closed without giving any further notice, in accordance with the provisions of the Air (Prevention and Control of Pollution) Act, 1981 & the Water (Prevention and Control of Pollution) Act, 1974.
