Attention is invited towards Writ Petition (Civil) No. 10106 of 2023 filed by HSK Infra Pvt. Ltd. (HIPL) in the High Court of Delhi against Union of India & Others wherein, the petitioner is aggrieved by the decision of CPWD in which the claim of the petitioner under the Vivad se Vishwas I-scheme, was rejected on the grounds of arbitration proceedings pendency before the Arbitral Tribunal. CPWD further mentioned that the claim was rejected stating that the scheme is not applicable to works contract.

In this connection, reference is invited towards this Department OM No. F.1/1/2023-PPD dated 22.06.2023 (copy enclosed) vide which it was already clarified that all cases including works contracts, which are otherwise eligible for relief under the scheme are eligible for relief under the scheme, even if a dispute with regard to the relevant contract is pending before a Court or Arbitral Tribunal. The Court/Arbitral Tribunal shall be kept informed about the action taken by the Government. It was also requested to review rejection of claims, as rejection of the claim was primafacie not correct.

With reference to M/o Finance OMs No. F.1/1/2023-PPD dated 25.05.2023 and dated 22.06.2023, now, DoE, M/o Finance has requested vide their OM No. F.17/13/2023-PPD dated 12.10.2023 (copy enclosed) to review rejection of claims of HSK Infra Pvt. Ltd. (HIPL), and extend the benefits due to the company under the said scheme, if admissible and defend the above on the grounds of arbitration proceedings pendency before the Arbitral Tribunal in respect of Writ Petition (Civil) No. 10106 of 2023.

In view of the above, it is once again requested to review of claim of HIPL and extend the benefits due to the company under the said scheme, if admissible and defend the above said Writ Petition (Civil) No. 10106 of 2023 keeping the interests of Union of India in line with the clarifications given above.

- The Scheme was announced by the Government in order to provide relief to MSMEs due to the problems being faced by them during the Covid period. The mandate of the scheme is to give reliefs to MSMEs on account of forfeiture of Bid Security/ Earnest Money Deposit, forfeiture of Performance Security, imposition of Liquidated Damages (LD) and the damages levied under Risk purchase. The scheme is applicable for all contracts which are otherwise eligible as per eligibility criteria provided in para 2 of this Department's OM No. F.1/1/2023-PPD dated 11.04.2023 and 02.06.2023 (copies enclosed).
- 3 .: It is clarified, however, that cases otherwise eligible for relief under the scheme shall remain eligible for relief under the scheme, even if a dispute with regard to the relevant contract is pending before a Court or Arbitral Tribunal. The Court/ Arbitral Tribunal shall be kept informed and claim amount shall also be suitably reduced, duly protecting the interest of the Government.

4. In this context, a representation dated 19.06.2023 of M/s Hsk Infra Pvt Ltd (HIPL) regarding claims of HIPL under Vivad se Vishwas I scheme is forwarded herewith for taking necessary action in this regard.

Government has been getting many references from Micro, Small and Medium Enterprises (MSMEs) regarding difficulties being faced by them in the last two years due to COVID 19 pandemic. The Government had provided certain benefits to the industry (including MSMEs) in Government contracts in the past. In continuation to the efforts of the Government in this regard, this Department had issued an OM of even number dated 06.02.2023. Many references have been received by this Department seeking clarifications on implementation of the scheme circulated on 06.02.2023. In this context, it has been decided to issue following instructions in supersession of this Department's OM of even number dated 06.02.2023 and 10.04.2023.

The following parameters will determine eligibility for benefits under this scheme:

3. The following amount shall be refunded by the procuring entities as a relief under this scheme after determining eligibility as per para 2 as above:

iii	Bid security (Earnest Money Deposit) forfeited	95% of the Bid security (Earnest Money Deposit) forfeited.
iv	Debarment of the contractor due to default in execution of eligible contracts/ eligible tenders under the scheme	Revocation of debarment by issue of an appropriate order by the procuring entity. The date of revocation shall be the date of such order. However, in case a firm has been ignored for placement of any contract due to debarment in the interim period (i.e. date of debarment and the date of revocation under this order), no claim shall be entertained.

Notes:

- i. No interest shall be paid on such refund/ relief amount in any case.
- ii. Deleted.
- iii. In case liquidated damages and/ or performance security and/ or damages under risk purchase have been deducted in the same contract, total relief will be 95% of LD forfeited plus 95% of the performance security forfeited plus 95% of the damages under risk purchase realized.
- iv. For cases where recoveries/ forfeiture for liquidated damages and/ or performance security and/ or damages under risk purchase have not materialized/ completed, the cases shall be dealt on the principles of this circular under para 3 as above.
- 4. Government e-Marketplace (GeM) has provided a dedicated link on their portal for implementation of this scheme. The link/ portal has the functionality for MSME Vendors to register their claims through its authorized personnel. For non- GeM

contracts of Ministry of Railways, MSME vendors will be required to register on IRePS (www.ireps.gov.in). The information regarding contracts for which claim is to be lodged on IRePS will be provided on GeM as well as IRePS. The broad features of this portal are as under:

- i. The registered contractor shall list out the eligible contracts on the portal. The list of the procuring entities is available through drop down menu on the portal. The details, such as contract number, contracting authority, Deducted/ forfeited amount, etc. will be submitted by the contractor on the portal.
- ii. GeM portal shall intimate through dashboard such details to the procuring entities to verify and refund the claim in terms of the eligibility etc. mentioned above and shall update the portal with the amount, date and transaction details of the payment. Procuring entities must approve/ reject the claim within 30 days of claim submitted by the contractor on the portal. Further, once claim is accepted, payment must be made and details are entered on the portal by the procuring entities within 30 days of the acceptance of the claim.
- iii. Pendency Reports to each procuring entity shall be provided by GeM.

5. The date of commencement of the scheme will be 17.04.2023 and claims can be submitted by 30.06.2023.

Respected sir,

We had applied for the vivad se vishwas scheme 1 -relief for msme on 21st april on the GEM portal as we were eligible for the scheme.

We had registered 2 claims as per the relief given as per the OM dtd 11.04.2023 of the ministry of finance.

Our claim no 1 of refund of performance guarantee with claim ID:

CL-66891682066096823 amounting to Rs. 1,90,00,000/-

Our claim No2 of refund of forfeited amount of LD with claim ID:

CL-7704168206936824 amounting to Rs. 2,96,18,385/-

Now as per the above said OM, the procurement authority that is in our case CPWD had to respond to the claims within 30 days but we got no response from CPWD.

When we contacted the GEM helpdesk regarding the same they advised us to contact the HOD/controlling ministry.

Then we had written an EMAIL to the DG, CPWD, the HOD of CPWD on 22.05.23, but we did not receive any response from them.

Then we registered a grievance on the CPGRAMS portal regarding the same on 26.05.2023 and then CPWD rejected our claims on 31.05.2023. The PG no of our grievance is DOURD/E/2023/0007167. The grounds for rejections of the claims are as under:

Claim No 1:-

Reason for claim rejection: "Others- M/s Hsk infra Pvt limited had invoked the arbitration in Nov. 2022." Claim Rejection Comment: "The agreement 34/EE/BCD1/2019-20 was determined under clause 3. M/s Hsk Infra Pvt. Ltd. itself had invoked arbitration in Nov. 2022. The statement of claim and statement of defence have already been submitted to the arbitral tribunal. M/s Hsk Infra pvt. Itd. vide his email dtd 15.05.2023 had sought 4 week time from the tribunal to file the rejoinder." Claim No 2:-

Reason for claim rejection :- "Others- Already moved the application under section 17 before the arbitral tribunal in Nov. 2022."

Claim Rejection Comment: "This Claim of LD is rejected, M/s Hsk Infra Pvt. Ltd. had already moved the application under section 17 before the arbitral tribunal in nov. 2022. The tribunal had made the final hearing and the decision is pending. Date of next hearing yet to be fixed by tribunal."

Then we had again written an Email on 31.05.2023 to the DG, CPWD, ADG Bhopal CPWD, SE and EE Bhopal CPWD where the work got executed, that as per the above said scheme there is no mention that the contracts which are under arbitration/litigation will not be eligible for the scheme and that their grounds for rejection were discriminatory and illegal and it was against the office memorandum Dated 11.04.2023 issued by ministry of finance and was also against the Budget announced by the Honourable Finance Minister of Govt of India.

We had once again written an E-mail to the DG cpwd, Adg Bhopal, Se bhopal and EE bhopal on 21st june 2023 where we even undertook that when our payment against the said claims are released to us, we will withdraw the concerned claims from our statement of claims. We had once again written an E-mail to the EE where our Grievance was registered wherein we once again undertook that we would withdraw the concerned claims from our statement of claims once the payment against the same is released to us.

In the ATR filed by the EE cpwd, the concerned officer dealing with the above said PG DOURD/E/2023/0007167 the contention of rejection of the claims changed that works contract are not in the scope of vivad se vishwas scheme. We once again sent a mail to the concerned officer on 24.06.2023 and a reminder on 26.06.23 on PG portal citing the O.M dtd 02.06.2023 of the ministry of finance wherein they have amended their own O.M dtd 11.04.2023 and clarified that this scheme is applicable for all contracts. Our said grievance was also closed by CPWD on 27.06.2023 without making us the payment. We have filed an appeal on the PG portal against the same on 27.06.2023. The appeal no is DOURD/E/A/23/0001361 for which we have not received any response till date.

Now this scheme was announced by the honourable finance minister of the Govt of India in the Amrit kal budget in the budget session of the parliament 2023-24.

Till date we have not received any relief as per the said scheme announced in the budget session of the parliament.

It is therefore humbly requested by your goodself to kindly intervene and please give us an opportunity for personal hearing if possible.
